Bar Tab Set by Dollar Limit

Bar Tab is set by Dollar Limit and is not limited by a time frame.

Bar Tab Set by Time Limit

Bar Tab is set by the amount consumed within the time frame specified.

Bar Tab Set by Per Person Per Time Frame

Bar Tab is charged by amount of people and has a set time limit. Two options exist for this beverage package, the standard drink package and the deluxe drink package.

Terms & Conditions

Decoration & Theming

If the client is decorating the function room, the client agrees to not stick anything to any painted surface in the venue and must have all decorations pre-approved by the functions manager. The client also takes responsibility for any damage caused as a result of decorating the room.

Belongings & Gifts

Clients are to ensure all belongings and gifts are collected at function completion (including decorations, theming and additional multimedia equipment).

Music and Entertainment

Please note that external entertainment (including your own DJ or live band) are permitted at Beach House Bar & Grill only with the pre-approval of the functions manager and are subject to significant conditions.

We also have the ability to play presentations through a DVD player on many of our plasma screens. If you would like to arrange this then we require that you bring in your DVD at least one day prior to your function date to test on our system. If you wish to do so- please ensure that it is edited onto one disc only.

Responsible Service of Alcohol

Beach House Bar & Grill practices the responsible service of alcohol at ALL times.

Management and security of Beach House Bar & Grill are entitled to refuse service or entry for any patrons not complying with the RSA guidelines.

All guests attending a function over the age of 18 must provide a proof of age card as specified by the government.

Liquor Licensing Queensland monitors and controls all licensed venues regarding the

advertisement of beverages. No events are allowed to advertise "free" or "discounted" beverages in any form. Any functions that have printed or advertised material associated with their event must first be approved by the functions manager to ensure that it complies with the Liquor Licensing Act of Queensland.

Catering is required for the minimum capacity of the rooms for all functions at Beach House Bar & Grill. No external catering is permitted other than a celebration cake. You also cannot bring any alcohol into the venue as Beach House Bar & Grill is a fully licensed Venue.

Minors (under18)

Our House Policy states that minors who are attending a function, are allowed in the venue until 10.00pm and must be accompanied by their parent or guardian.

They also will be issued with a wrist band to ensure they are easily detectable. If a minor removes his/her wristband then Venue Security will ask the minor and his/her parents to leave the venue.

If a minor is at any stage discovered with an alcoholic beverage or has consumed alcohol then he/she and their parents will be asked by Venue Security to leave the venue.

Minors are not allowed access (even when accompanied by and adult) to other areas within the Venue i.e. Main Bars, TAB etc.

In the instance where the Venue is not notified of any minors attending a function, Beach House Bar & Grill can refuse entry even if the minor is with their parents/legal guardian.

Booking, Deposit & Payment

Tentative bookings are taken however no formal booking is in place until all agreements have been executed and the deposit has been paid in full.

Final payment is required 2 working days prior to the event. Any further incidentals will be charged to your credit card on the date of your function.

Payment can be made by credit card (phone/personally), Cash (personally), Cheque (post/personally) or directly into our bank account.

If paying in person, an appointment needs to be arranged with the Functions Manager.

Should you require a Tax invoice please request this from the Functions Manager.

Pricing listed throughout the Functions document including food, beverage and room hire is subject to change without notice.

Once your deposit is paid, however, the prices applicable at that time will remain current for a period of 6 months.

Beverage prices are subject to change without notice and are based on CPI increases.

Cancellation policy
